## Qalaa Holdings Scholarship Foundation (QHSF)

- The QHSF was established in 2007 by Qalaa Holdings and today stands as one of the largest private-sector funded scholarship programs in Egypt open to scholars pursuing masters and doctoral degrees in all disciplines.
- **In June 2017**, QHSF celebrated its eleventh anniversary. The Foundation has granted more than 184 scholarships to date to students from 14 governorates across Egypt — including Cairo, Giza, Alexandria, Menoufia, Ismailia, Assiut, Gharbeya, Minya, Daqahleya, Qalyubeya, Aswan, Fayoum, Damietta, and Beni Suef.
- The QHSF takes pride in being open to all academic disciplines, with an eye to nurturing creativity and excellence in all its forms.
- Applicants may pursue the subject they are most passionate about. The main condition is that they be accepted at a top school in their field of study before applying for a QHSF award — and that they agree to return to work in Egypt following their graduation.
- Scholars have studied disciplines ranging from engineering, business, medicine, neuroimaging, filmmaking, anthropology, human rights, and law to architecture, development, economics, and museums, galleries, and contemporary culture.
- Qalaa subsidiaries TAQA Arabia and the Egyptian Refining Company (ERC) started to award two additional scholarships in 2017: one focusing on candidates working in the field of renewable energy (TAQA) and the other giving priority to students from the district of Matarreya (ERC). Both scholarships are managed by QHSF.
- Universities attended by scholarship recipients include:
  - Harvard, Stanford, Columbia, Cornell, University of California Los Angeles (UCLA), New York University, Tufts, University of Pennsylvania, Duke, and Syracuse in the United States.
  - Oxford, Cambridge, Manchester, University College London, Imperial College London, London School of Economics, City University, and Warwick in the United Kingdom.
  - Several top European universities including Sweden's Lund University, the Universities of Heidelberg and Bonn in Germany, University of Helsinki in Finland, Wageningen in the Netherlands, Grenoble Institute of Technology in France, and Ca'Foscari University of Venice in Italy.
  - MBAs at top business schools including INSEAD, London Business School, and ESADE in Spain as well as Wharton, Columbia, and Duke in the United States.
